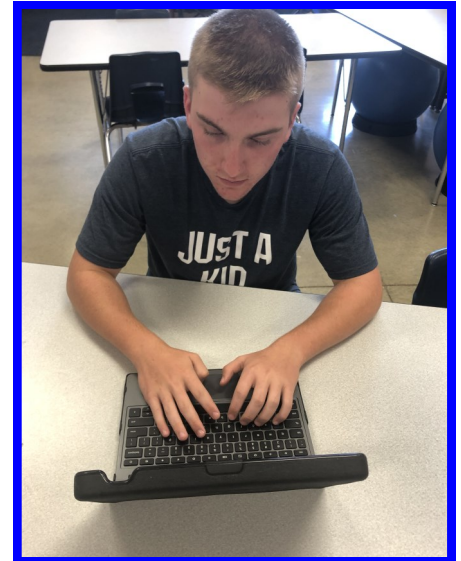

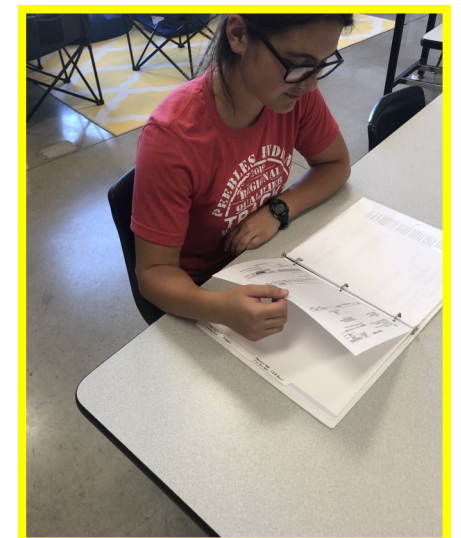
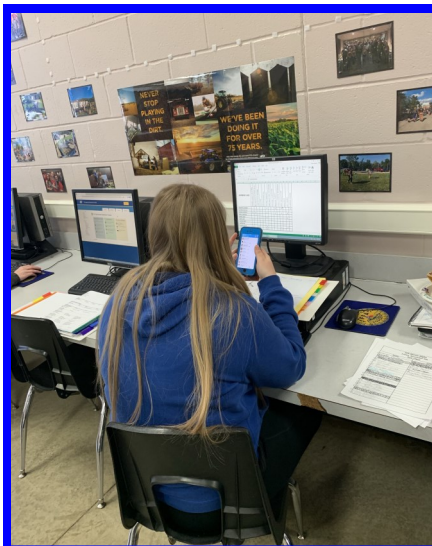
Officer Meetings

Students will have the opportunity to learn about 21 days developmental process of chicks from fertilization till hatch. Our members are starting to monitor the temperature and humidity of incubators, learn to check stages of growth, as well as look for deformities in the chicks during and after hatching. Members will continue this process throughout the upcoming months. We are so excited to get this opportunity and can't wait to greet the chicks as they hatch in September.
